Your Excellency:

I am writing to inform you that on the doctor's advise I advised Mr. Gerald Chalifour to take a year off from the Seminary for reasons of health. The doctor could not find anything physically or anatomically wrong with him but he is suffering from a severe case of fatigue and is about thirty pounds underweight. In this situation it is practically impossible for him to follow the seminary life and studies.

This present condition I think is explained by his past history. In parochial school he skipped a grade; he made his high school in three years by going to Summer School every summer; he entered college at the age of fifteen and was accelerated through college completing it in three years; when he came to us for Theology he was just nineteen years old. This constant strain of studying without proper time for vacation for a growing boy has apparently accumulated to cause his present condition of fatigue.

Had he continued on at the present time he would need the full extent of a dispensation for age before Priesthood since he would only be 22½ years old. Taking this year out he will still be under age for the Priesthood. The doctor and I consulted at length about this situation and we deemed it the prudent thing to do to advise him to go home and rest and build up his strength. He is a good boy and a very likely candidate for the Priesthood so I am sure that if he profits as he should by his leave of absence he will be able to continue and make a good priest.

I trust that our decision will meet with your approval.

Dear Bishop,

This is to acknowledge your letter of June 24. I would have written sooner but my energy level has been somewhat at low tide. I wish to thank you for granting me retirement effective October 31st but more importantly for understanding the reasons why I had to request it.

You suggested that I keep in touch with you and I'd like to start now by sharing some thoughts with you. About my residence....in 1985 when I became chaplain at Catholic Medical Center, the hospital did not provide quarters for the chaplain. I inquired but no rectory on the west side had room to accommodate me so I built a home where I am now living. I have made arrangements with one of my sisters for her to buy it over the next few years and then I would like to move to a place like the St. John the Baptist rectory to be with fellow priests. Years ago I had a dream that when I'd retire I would buy a place in Florida for the winter months and spend the summers doing ministry in New Hampshire. But now with Stan Skora gone (and Frs. Richer, Houle, Veillette, Belanger, Bouley etc.) I find that all my friends are gone and I'm certainly not going to go spend the winter in Florida alone. I might go for a few weeks if I can find someone to go with. My last vacation was 10 days in April 1990.

About my ministry....as I told you I do not want a rocking chair retirement. After I leave St. Teresa's at the end of October, I would like to take the winter months off except for weekend help if needed in any Manchester parish. Winter travel is not exactly my favorite thing. Come spring, I would like to go on a sort of 'Kelley Temporary Services' basis, being available to replace temporarily priests who die, who are sick or who are alone in a parish and cannot get a replacement for their vacation, retreat or other legitimate absence. In this way I hope to be able to be of service to the diocese for as many years as possible.

When you were kind enough to invite me for lunch in January, you asked why I wanted to retire. Not wanting to take up any more of your time, I gave you the short answer that I was 'tired'. Permit me to expand on that answer now.

For the past 40 plus years I have suffered greatly from the effects of stress. Coupled with the fact that I have always been a workaholic and a perfectionist, this has made life very difficult at times. I have been using tranquilizers on and off for over 40 years, always under a doctor's prescription. This stress has been manifested by headaches, gastro-intestinal difficulties, sleeplessness, chronic fatigue, intermittent hypertension (190/110), soreness in shoulders and neck and dizzy spells. On this last matter, a carotid bilateral ultrasound doppler in March 1992 showed negative for any cerebral circulation problems. For the past 5 years I have suffered anxiety attacks which cause nightmares, always focusing on the same concern, i.e. I won't be on time for whatever.

While my problem with stress and tension is not as clinically demonstrable as cancer or heart disease, it is nonetheless just as debilitating.

That is the reason why I am asking for retirement after 40 years of being 'au devoir'. I want to keep on working but feel that I need a respite from a permanent assignment and the accompanying schedules. I will admit that I felt guilty about asking when I thought of others who have been ordained longer than I have but are still working. But Dr. Guertin-Ouellette and the Rev. Roger Couture, o.m.i., my spiritual director, made me understand and accept the fact that I must consider my situation in asking for retirement and not that of others.

The exact date of my retirement of course depends on the convenience of the diocese. Personally, I would like it to be next October 31st. I have made

will be all p; aid up with my October check. As I am forfeiting any monthly stipend from the Retired Clergy Fund, I would like my pledge to be paid out of earnings rather than savings.

Again I would state my intentions, as spelled out in my January 1st letter to you, that my first year's monthly retirement stipend be given to the Diocesan Seminarians Fund, the second year to the Sick Priests' Fund and future years to be determined on a yearly basis. I live a simple and frugal life and believe that I have enough to finish my days but I would reserve the right to begin collecting in the future if ever the need should arise. Who can know the future but the Lord!

I deeply regret the concern I have caused you in the past few months over my irresponsible actions of the late 1960's and early '70's. I ask for your forgiveness and prayers.

I wish also to thank you for the stole you presented to me at the convocation to mark my 40th. It was a nice gesture albeit a rare expression of affirmation from the diocese.

Please rest assured of my prayers for you in your most difficult job as Ordinary.

I will admit that I felt guilty about asking when I thought of others who have been ordained longer than I have but are still working. But Dr. Guertin-Ouellette and the Rev. Roger Couture, o.m.i., my spiritual director, made me understand and accept the fact that I must consider my situation in asking for retirement and not that of others.

The exact date of my retirement of course depends on the convenience of the diocese.. Personally, I would like it to be next October 31st. I have made a pledge of \$5,000 to Mt. Carmel Nursing Home in memory of my father. Catholic will be all p; aid up with my October check. As I am forfeiting any monthly stipend from the Retired Clergy Fund, I would like my pledge to be paid out of earnings rather than savings.

Again I would state my intentions, as spelled out in my January 1st letter to you, that my first year's monthly retirement stipend be given to the Diocesan Seminarians Fund, the second year to the Sick Priests' Fund and future years to be determined on a yearly basis. I live a simple and frugal life and believe that I have enough to finish my days but I would reserve the right to begin collecting in the future if ever the need should arise. Who can know the future but the Lord!

I deeply regret the concern I have caused you in the past few months over my irresponsible actions of the late 1960's and early '70's. I ask for your forgiveness and prayers.

I wish also to thank you for the stole you presented to me at the convocation to mark my 40th. It was a nice gesture albeit a rare expression of affirmation from the diocese.

Please rest assured of my prayers for you in your most difficult job as Ordinary.

I had to refuse a weekend at Hampton Beach and all the Masses at the Cathedral the last weekend of the month.

Even though my cancer is **s**till in remission I have developed two problems which seem to defy all treatment. I have high blood pressure which causes dizziness and a four month old sinus infection which causes severe headaches. Because of these medical problems, I don't know what the future will bring. The Diocesan Retirement Policy states that a priest may retire after 40 years of ordination and with six months' notification to the Bishop. I was originally a member of the class ordained May 19, 1951 but due to a year lost in theology because of illness, I was ordained on June 7, 1952.

Accordingly, and because of life-long health problems which have been exacerbated by age, I hereby request retirement effective July 1, 1992. I shall continue to be available for ministry at St. Teresa's Manor as long as needed and thereafter, health permitting, for short term assignments in diocesan emergencies such as the death or illness of a priest and for priests unable to get a replacement for their vacation or other legitimate absences.

After reading your letter of last September detailing the financial concerns of the diocese, I would further request that my first year's monthly retirement stipend be given to the Diocesan Seminarian Fund, the second year's to the Sick Clergy Fund. Future years' recipients will be determined on a yearly basis.

I will make a note of my request for retirement on my Clergy Personnel Profile booklet when we receive it later this month.

It is a month today, on December 8th, that I left Manchester and so I thought I would drop you a line to keep you informed.

As you probably know, Charlie Crosby drove me down and was down here two days before flying back. We did some visiting including EPCOT Center which we both found rather disappointing.

I am staying in a condominium belonging to a couple from Londonderry and which is situated on an island off the coast of Duendin just north of Clearwater. There are 400 apartments and it is strictly a 'Geritol' set which lives here. I believe that I am probably the youngest person around. The apartment is spacious and very comfortable. Outside availabilities include a swimming pool, shuffleboard and tennis courts and a recreation hall with pool tables, etc. The weather has been so cold though that the pool and the courts have not seen much business in the past few weeks. On the morning of December 26th, we hit a low of 19 degrees.

My daily schedule (or rather, non-schedule) runs thus: I have been sleeping later than I used to at home. When I get up I have breakfast, say my Office, read the morning paper and offer Mass just before lunch. In the afternoons I usually go out for a good walk, read and catch up on long overdue correspondence. After supper I do some more reading, watch some television and go to bed not too late.

As to the state of my health: I have gotten rid of the incessant coughing that came with my pneumonia of October and November although I still have some pains in my lungs but not as bad as it was in November. I am sleeping more than the two or three hours that I had been getting home every night but I still have to take something to help me sleep. All in all I still haven't climbed to the top of the hill yet but I do believe that I am headed in the right direction. The hardest thing of all has been getting used to doing and taking all day to do it. The temptation is always there to throw everything in the car and head back to N. H. I pray that the Lord will help me to understand that that is not what I need.

From what I hear from the grapevine (I have had no direct contact with St. Theresa's since I left) Fr. Allard is doing real well at St. Theresa's. I am most grateful to you for naming someone as administrator in whom I can place my trust and not have to worry about what is happening back home.

May your New Year, the year of the 100th of the diocese and the 50th of St. Theresa's, be a Happy, Holy and Healthy One!

## PERSONAL INTERVIEW OF BISHOP GENDRON WITH FR. GERALD CHALIFOUR, PASTOR

# SAINT THERESA PARISH MANCHESTER, NEW HAMPSHIRE JANUARY 23, 1982

I had a nice visit with Fr. Chalifour and commented with him about the parish visitation and especially the Parish Council Meeting last night. I declared that I was very happy with what was happening in the parish. The parish development is happening on a very good basis and going in the right direction.

I commented that I thought the spirit of the parish was wholesome and it was a family kind of an attitude, people concerned with each other. Father did indicate on the other hand that sometimes there is a problem with the people who have been here forty years and involved and the newcomers who are not willing to become involved or the older folks don't seem to let go of some of the responsibilities although Fr. Chalifour does encourage them to find new members for their committees and so forth.

I then emphasized the need to develop the committees and the leadership of the committees and to delegate the responsibilities to new members of committees. The people do not seem to have much initiative. They will attend parish council meetings but then this sort of terminates there in many instances other than when Father seems to motivate them and support and encourage them. He himself has a tremendous amount of initiative and orientation and is enthusiastic. They seem to love him and appreciate him and he had done very well in the parish. They act more on the parish council as a consultative body rather than as an active, responsible group.

Father indicated to me to motivate the people, to move them literally, in so many instances towards being the church alive. Father has really a good concept in terms of how he understands the parish and its growth and development and I commented on that matter and endorsed him and affirmed him. I did indicate the need to select one or two goals that they might work on next year.

Father then moved to another topic which was in his mind - the low morale of our priests due primarily to frustration of the priest in terms of not being able to achieve what they'd like or again not being able to get affirmation from the Bishop or the diocese in terms of what they achieve when they do well. He had some very good points in terms of priests really feeling rather disgusted at times or kind of down or being taken for granted but what he really was saying is that they need a little bit of stroking, they need some encouragement, they need to be appreciated and they need to hear about how much we appreciate what they are doing. I thought he made some good points. I think he was revealing himself, because he needs an awful lot of stroking although he said he didn't, but I presume he does from his past and so forth, I think that is true. He indicated that although he is giving much support to say, vocations. to building, he's done extremely well in terms of administering buildigns and properties he's never been asked to be on the Building Board or on the Vocation Board or for any other service for the diocese so I guess what he was kind of saying was that he was not appreciated, he's not been affirmed sufficiently for his needs. He had no suggestions to make, on the other hand he said he was not able to accept any board membership because he was always too busy here with just being alone. He did say that he himself did feel a lot of frustrations at times because there is so much to be done and he has been unable to do it all. He has good planning, good imagination, good thoughts in terms of growth and development but he lacks the help, the time and the energy to accomplish all that he wants. but he is not an idle man - he is very busy, he is dedicated, he is a little bit overly responsible in that he will not delegate sufficient responsibilities or trust other people to handle the responsibilities, he does not take his days off or vacations. He says he is a diabetic and is on the pill, most of the time he feels fairly well but then again gets very tired and has to go to bed at 6:30 sometimes.

One question he brought up was do we have in our plans to consider self-insurance in the medical field. I told him I did not know when we had looked at this but we would be happy to consider it. He feels it is very, very costly to insure someone, say a janitor with his family, the cost being \$1800.00 a year for just that one person. He feels that if we had a self-insurance for property and liability it would be helpful to the diocese and maybe we ought to look into the medical insurance coverage for ourselves. I probably think he was trying to make sure that he was not too agressive and yet he was very honest and kind about it and yet he pointed out a lot of his frustrations which I presume he has had for a long time, but he is in good spirits and has done well and if he is going to take some time off he thinks in May he might find time at that point.

This concludes the conversation with Father Chalifour.

I wonder if you could do me and the other 126 pastors of the Diocese of Manchester a favor.

I don't know who makes out the schedule for the diocesan collections every year but evidently it is someone who is not a pastor.

Here is the problem: On Saturday, August 15th, we had the Feast of the Assumption with its attendant collection. The next day on August 16 (for those who come to the anticipated Sunday Mass, the same day) we had the regular parish Sunday collection and the special collection for Manchester Mission in South America. Three collections in two days. And the same thing will happen in December when we have both the Sunday collection and the Catholic University collection on the 6th and then the Immaculate Conception collection on the 7th and the 8th.

Msgr. Lesmerises has told me several times that if Auburn ever opened up, he would be greatly interested. If it were to happen that he'd go to St. Peter's, I would be breatly interested in St. John the Baptist.

When we discussed the vacancy in Franklin several weeks ago, I told you that there were three things up there that would possibly prove too much for me, namely, the school, the cemetery and the hospital. St. John the Baptist has none of these. As far as I know, its biggest problem is the half million dollar parish debt. We all like to believe that we have a few strong points. I believe that one of mine is finances and would dare to believe that I have proven that in Suncook, HUdson and Farmington.

The question necessarily comes up of my health. Since I have seen you last, there has been a marked improvement although it is not quite 100% yet. I believe that a change of scenery might not be at all harmful and with associates I would be able to take my vacations, sadly neglected in the past and part of the cause of my current medical problem. I was away for ten days last fall and nine days in February of 1973. In 1972 I didn't take any vacation at all.

My doctor is in Manchester and I would consider it a great favor if I could get closer to him.

Again, I realize that this is all based on "if's"...if Fr. Montplaisir should leave St. Peter's and if Msgr. Lesmerises should replace him, but I thought that you would like to know what is going through my head.

I have heard of a few priests who indicated that they did not need the raise in salary and have donated the equivalent back to the church. I note in your letter the generosity which you have shown to the parish in Farmington.

As you know, this whole question of salary has received rather close attention throughout New England as well as across the country. I certainly trust that opinions such as your own will be as heavily weighed as the opinions of those who are seeking higher salaries.

Dear Bishop Primeau,

I write because, even two weeks after your letter of October 26th dealing with new salary schedules, I am still very much upset. I have talked to a number of priests and the consensus seems to be that our previous salaries were more than adequate and that the recent raise is totally unneeded.

Diocesan priests are not monks and therefore do not have the vow of poverty, but they certainly should live the spirit of poverty. And yet we find them today, at a time when both parishes and parishioners have a hard time making ends meet, living like "les Seigneurs d'un autre siècle." They have big cars, summer cottages, boats, the absolute best in stereo equipment.....the list is almost endless of things they have that the average parishioner has to do without. Add to my new salary of \$4620 a year approximately \$600 in Mass stipends and I earn, clear, over \$5000 a year. I am housed, fed, and have my medical insurance and retirement plan paid by the parish. And then I look at my parishioners who work at Davidson Rubber at 2.55 an hour or just over \$5000 a year and who on this amount have to raise a family and I am ashamed on Sunday to get up in the pulpit to ask them to increase their already very generous contributions. When I was ordained, the salary scale was \$50 a month. Ridiculous, but we survived! A little later Bishop Brady gave us a \$300 a year raise on a Thursday and asked \$200 back on the following Monday for the Monastery of the Precious Blood. Again we survived. When discussion arose three years ago on the Christmas collection, those who opposed giving it to the pastor said it was "unprofessional" Are these the same ones who now clamored for a raise on the basis that their income should be more "professional"? Are we priests dedicated to church and people or just professional religious functionaries? For the past two months Senate meetings have been concerned with the decreasing number of church-goers. Could priests' life-style be a contributing factor to this?

I was also disturbed by your paragraph "This approval is not meant to preclude any further ongoing study of this question etc." Do I interpret this correctly to mean that salaries could go up some more? I doubt that it means they would go down.

The easy answer that could be given me would be that I not take my whole salary. This I have been doing since I came to Farmington and further, three years ago, when the parish couldn't afford a new car for the nuns, I coughed up. But I'm afraid that I might be establishing a very bad precedent for my successor.

Again, Bishop, I write to you with all due respect. It's just that I'm quite put out by all this salary business. Please excuse any impropriety on my part in this letter.
