**** NARRATIVE

I ATTENDED A VIDEO TAPED INTERVIEW AT THE STRAFFORD COUNTY ATTORNEYS OFFICE CONDUCTED BY NANCY HARRIS. NANCY HARRIS SPOKE WITH REGARDING SEVERAL EPISODES OF UNWANTED SEXUAL ADVANCES BY FATHER ROGER FORTIER THE RESIDENT PASTOR AT ST. PETERS CHURCH IN FARMINGTON. (SEE TRANSCRIPT OF INTERVIEW FILED UNDER THIS CASE NUMBER). DURING THE INTERVIEW EXPLAINED HOW THERE WAS MUTUAL MASTURBATION AND ORAL SEX PERFORMED BY BOTH PARTIES ON EACH OTHER. ALSO GIVES VERY DETAIL DESCRIPTIONS OF THE HOUSE IT'S CONTENTS AND LOCATIONS OF ITEMS WITH POSSIBLE EVIDENTURY VALUE.

BASED ON THE INFORMATION GAINED IN THE INTERVIEW A SEARCH WARRANT WAS PREPARED AND NAMED IN IT WAS PORNOGRAPHY AS WELL AS ANY OBJECTS THAT COULD BE CONSIDERED AS BEING SEXUAL IN NATURE. SEE ATTACHED COPY OF WARRANT AND RETURN.

OFFICERS MANGUM AND FOGARTY AS WELL AS LT. MCGOWAN AND SGT. WILLEY, ASSISTED ME IN SERVICE OF THE WARRANT. THE WARRANT WAS ISSUED ON THE RESIDENCE LOCATED AT 90 CENTRAL ST. IN FARMINGTON THIS PROPERTY IS THE RECTORY OF THE ST. PETERS CHURCH IN FARMINGTON. THIS PROPERTY IS THE RESIDENCE OF FATHER ROGER FORTIER AND ONLY FATHER FORTIER.

OFFICER MANGUM AND I WENT TO THE RESIDENCE OF JUDGE FRANKLIN JONES TO PRESENT THE WARRANT AND AFFIDAVIT FOR ISSUANCE. JUDGE JONES REVIEWED THE EVIDENCE DESCRIBED IN THE AFFIDAVIT AND THE STATEMENTS MADE AND FOUND THAT PROBABLE CAUSE EXISTED TO ISSUE THE WARRANT. JUDGE JONES ASKED WHEN THE WARRANT WAS TO BE SERVED AND TOLD HIM IT WOULD BE SERVED UPON MY RETURN TO FARMINGTON. JUDGE JONES UNDERLINED THE FACT THE WARRANT WAS VALID AND COULD BE SERVED AT NIGHT. OFFICER MANGUM AND I RETURNED TO THE FARMINGTON POLICE DEPARTMENT AND MET WITH THE OTHER OFFICERS TO ISSUE ASSIGNMENTS. SGT. WILLEY AND I WERE ASSIGNED THE TASK OF INTERVIEWING FATHER ROGER FORTIER AND OFFICERS MANGUM AND FOGARTY ALONG WITH LT. MCGOWAN WERE TO CONDUCT THE SEARCH.

TWO FARMINGTON MARKED POLICE CRUISERS WERE TAKEN TO FORTIER'S RESIDENCE. SGT. WILLEY WAS GIVEN A COPY OF THE SEARCH WARRANT AND WHEN FORTIER ANSWERED THE DOOR HE WAS SERVED IN HAND AND THE WARRANT WAS EXPLAINED. ALL OFFICERS ENTERED THE HOME WITHOUT INCIDENT AND OFFICERS MANGUM AND FOGARTY AS WELL AS LT. MCGOWAN WENT TO THE UPSTAIRS AREA OF THE HOUSE AND BEGAN A SYSTEMATIC SEARCH. I EXPLAINED TO FORTIER THE ALLEGATIONS AGAINST HIM AND EXPLAINED THAT HE WAS IN NO WAY OBLIGATED TO TALK WITH ME, FORTIER SAID HE UNDERSTOOD. I ASKED TO BE ALLOWED TO TAPE THE CONVERSATION WE WOULD HAVE SO NO WORDS WERE MIXED AND NOBODY WAS MISQUOTED, FORTIER AGREED.

I BEGAN THE INTERVIEW BY INTRODUCING MYSELF AND SGT. WILLEY ALSO I DESCRIBED WERE WE WERE AND THAT FORTIER WAS PRESENT. THE INTERVIEW TOOK PLACE DIRECTLY INSIDE THE EAST DOOR IN A SMALL SITTING ROOM. SEE TRANSCRIPT OF THE INTERVIEW WHICH ACCOMPANIES THIS REPORT. AT ONE POINT IN THE INTERVIEW I TOLD FORTIER THAT HE WAS BEING ACCUSED OF SOME POSSIBLE UNWANTED SEXUAL ADVANCES AND ASKED HIM ABOUT THAT CLAIM. FORTIER LOOKED VERY NERVOUS AND SAID "I, HAVE AH NO COMMENT". I SAID "NO COMMENT RIGHT NOW" FORTIER SAYS "NO". THE REST OF THE INTERVIEW WAS SPENT IN AN ATTEMPT TO SOLIDIFY FACTS THAT GAVE IN HIS INTERVIEW, THIS WAS SUCCESSFUL IN THAT, FORTIER SAID HE GAVE \$5.00 PER WEEK TO FOLD BULLETINS AND THAT WOULD STAY AT HIS HOUSE NEARLY EVERY FRIDAY AND SATURDAY NIGHT. FORTIER STATES THAT THE TWO WOULD GO OUT TO DINER AND THEM RETURN TO THE RECTORY TO WATCH MOVIES IF THERE WAS NOTHING ON TV. FORTIER SAID THAT HE BOUGHT A RED BANK/STRONG BOX FOR AND THAT IS WHERE HE KEPT HIS MONEY. MENTIONS THIS BANK AND DESCRIBES EXACTLY WERE THE KEY TO THE BANK WAS LOCATED.

DURING THE COURSE OF THE INTERVIEW FORTIER BECAME EXTREMELY NERVOUS AND THEN "SHUT DOWN". FORTIER GOT UP OUT OF HIS CHAIR AND WENT TO A SEPARATE ROOM WERE HE PLACED A CALL TO HIS LAWYER (A PARISHIONER). FROM THAT POINT ON FORTIER SPOKE VERY LITTLE AND WHEN HE DID IT WAS AT A MUMBLE. SGT. WILLEY AT THAT POINT TURNED OFF THE TAPE AND STOPPED THE INTERVIEW.

I WENT TO THE SECOND FLOOR AND ASSISTED LT. MCGOWAN AND OFFICERS FOGARTY AND MANGUM. WHEN I ARRIVED I NOTED THAT OFFICER MANGUM WAS LOGGING ALL EVIDENCE AND OFFICER FOGARTY WAS CONDUCTING A VIDEO VERSION OF THE SEARCH AND ITEMS FOUND. ALL OFFICER INVOLVED IN THE SEARCH WORE RUBBER LATEX GLOVES ON THEIR HANDS. LT. MCGOWAN SEARCHED AREAS AND TOOK STILL PHOTOGRAPHS OF POSSIBLE EVIDENCE AND ITEMS THAT WERE SEIZED. I DONNED RUBBER GLOVES AND BEGAN TO ASSIST IN THE SEARCHING PROCESS. I RECORDED ITEMS SEIZED FOR THE RETURN ON THE WARRANT AND TOOK ITEMS SEIZED TO OFFICER MANGUM WHO WOULD LOG AND TAG THE EVIDENCE.

DURING THE SEARCH I LEFT THE RESIDENCE TWICE ONCE TO RETRIEVE MORE FILM AT THE FARMINGTON POLICE DEPARTMENT AND ONCE AT THE REQUEST OF CHIEF ROBERGE AFTER THE SECOND TIME I DID NOT RETURN TO THE HOUSE. DURING MY FIRST TRIP TO THE FARMINGTON POLICE STATION I TOOK THE CRUISER THAT THE EVIDENCE WAS BEING STAGED IN (THE TRUNK). WHEN I ARRIVED AT THE FARMINGTON POLICE STATION I REMOVED THE EVIDENCE AND BROUGHT IT INTO THE FARMINGTON POLICE DEPARTMENT AND BEGAN TO STAGE THE EVIDENCE IN THE "MEETING ROOM". SEE THE ITEMIZED LIST OF ITEMS SEIZED WHICH ACCOMPANIES THIS REPORT.

DURING THE COURSE OF THE SEARCH I OBSERVED SEVERAL ITEMS THAT WERE SPECIFICALLY DESCRIBED BY IN HIS INTERVIEW. SUCH AS THE BED SHEETS THAT WERE MULTI-COLORED, BLACK SUIT CASES WHICH CONTAINED PORNOGRAPHIC VIDEOS AND PORNOGRAPHIC MAGAZINES.

I LEFT THE FORTIER RESIDENCE AT THE REQUEST OF CHIEF ROBERGE AND RETURNED TO THE FARMINGTON POLICE DEPARTMENT AND BEGAN A WARRANT FOR

THE ARREST OF ROGER A. FORTIER. THIS WARRANT WAS AS A RESULT OF EVIDENCE FOUND AT THE RESIDENCE AND STATEMENTS MADE BY THE VICTIM IN THIS CASE. THIS WARRANT AND SUPPORTING AFFIDAVIT WERE REVIEWED AND ISSUED BY JUSTICE OF THE PEACE KATHY VICKERS.

DURING THE TIME I STARTED THE ARREST WARRANT AND SUPPORTING AFFIDAVIT FOR ROGER FORTIER OFFICERS FOGARTY AND MANGUM AS WELL AS LT. MCGOWAN AND SGT. WILLEY RETURNED TO THE PD. I WENT TO THE FORTIER RESIDENCE AT APPROXIMATELY 0130 HOURS ON 10/28/97 AND AT THAT TIME PLACED ROGER FORTIER UNDER ARREST AND TOOK HIM INTO CUSTODY. **** NARRATIVE

ON NOVEMBER 4, 1997, I RECIEVED AN EXTENSION OF ONE PARTY INTERCEPT, PERMISSION FROM NEW HAMPSHIRE ATTORNEY GENERAL'S OFFICE. ATTORNEY MARK ATTORRI REVIEWED THE EVIDENCE AND PROBABLE CAUSE FOR THE ONE PARTY INTERCEPT AND GAVE THE EXTENSION THROUGH NOVEMBER 5TH AT 9 P.M.

ON NOVEMBER 5TH, AT APPROXIMATELY 2:15 P.M., I WENT TO THE RESIDENCE ON

ALSO PRESENT WAS NANCY HARRIS FROM THE STRAFFORD COUNTY ATTORNEY'S OFFICE, AN INVESTIGATOR, THOMAS HART, ALSO FROM THE STRAFFORD COUNTY ATTORNEY'S OFFICE.

WE WAITED WITH MR. UNTIL RETURNED HOME FROM WORK AT APPROXIMATELY 2:30 P.M., AT WHICH TIME WE BRIEFED ON QUESTIONS THAT HE MAY WANT TO COVER IN CONVERSATION WITH ROGER FORTIER.

AT APPROXIMATELY 2:40 P.M., MADE A CALL TO SAINT JOSEPH'S RECTORY IN NASHUA, WHERE ROGER FORTIER IS CURRENTLY ASSIGNED ON ADMINISTRATIVE LEAVE. FIRST SPOKE TO A SECRETARY OR OTHER PERSON AT THE RECTORY WHO ANSWERED THE PHONE, SHE TRANSFERED CALL TO ROGER FORTIER. WHEN FORTIER PICKED UP THE LINE, THE ONE PARTY INTERCEPT WAS INITIATED AND A TAPE OF THE PHONE CONVERSATION WAS STARTED. THE ENTIRE PHONE CALL WAS TAPED, THAT TAPE HAS BEEN BROUGHT TO THE STRAFFORD COUNTY ATTORNEY'S OFFICE AND THEN RETURNED TO THE FARMINGTON POLICE DEPARTMENT WHERE IT IS CURRENTLY LOGGED AS EVIDENCE IN THE CASE STATE V. FORTIER.

DURING THE PHONE CALL SPOKE TO FORTIER ABOUT THE POLICE SPEAKING TO HIM AND WANTING TO CONDUCT A VIDEO TAPED INTERVIEW. SAYS ON THE TAPE THAT HE IS VERY SCARED. FORTIER DOES NOT GIVE ANY ADVICE AT THAT POINT, HOWEVER, SAYS AT ONE POINT IN THE CONVERSATION TO FORTIER, "IF I TELL THEM IT WAS CONSENUAL, WILL YOU STILL GET IN TROUBLE", TO WHICH FORTIER REPLIES, "IF YOU DON'T TELL THEM ANYTHING, I WON'T GET IN TROUBLE". THE PHONE CALL LASTED APPROXIMATELY SEVEN MINUTES. AT APPROXIMATELY 2:47 P.M., FORTIER ABRUPTLY ENDED THE PHONE CONVERSATION BY TELLING THAT SOMETHING HAD COME UP THAT HE HAD TO TAKE CARE OF. SAID GOOD-BYE AND ENDED THE CONVERSATION.

DID LEAVE FORTIER WITH THE IMPRESSION THAT HE WOULD BE PARTICIPATING IN A VIDEO TAPED INTERVIEW AT THE STRAFFORD COUNTY ATTORNEY'S OFFICE AS A POSSIBLE VICTIM IN THIS CASE.

FORTIER ALSO MENTIONS DURING THE PHONE CONVERSATION THAT THE POLICE HAD BEEN TO THE RECTORY AT SAINT PETER'S CHURCH IN FARMINGTON AND SEIZED HIS COMPUTER SYSTEM. ASKED WHY THE POLICE WOULD HAVE SEIZED HIS COMPUTER AND FORTIER'S REPLY IS HE HAS NO IDEA, HE DOESN'T THINK THAT THERE IS ANYTHING ON IT AND THAT HE ONLY CONDUCTED CHURCH

I WENT TO ST. JOSEPHS CHURCH RECTORY IN THE CITY OF NASHUA AND EFFECTED AN ARREST WARRANT ON FATHER ROGER FORTIER. THE WARRANT CHARGES FORTIER WITH FETONIOUS SEXUAL ASSAULT. I WAS ESCORTED TO THE RECTORY BY NASHUA PATROL UNIT 12. THE ARREST WAS CARRIED OUT WITHOUT INCIDENT AND FORTIER WAS TRANSPORTED BACK TO THE FARMINGTON POLICE STATION WHERE HE WAS BOOKED AND TRANSPORTED TO THE ROCHESTER DISTRICT COURT FOR ARRAIGNMENT. FORTIER WAS ARRESTED AT 12:16, PM AND HANDCUFFED IN THE FRONT OF HIS BODY HANDCUFFS WERE DOUBLE LOCKED AN CHECKED FOR TIGHTNESS. THE STARTING MILEAGE FROM NASHUA IN THE MARKED 1996 CRUISER WAS 47189. UPON ARRIVAL AT THE FARMINGTON POLICE DEPARTMENT MILEAGE WAS 47257 AND THE TIME WAS 1:30 PM.

WHILE AT ST. JOSEPHS CHURCH IN NASHUA FATHER DALLAIRE, THE RESIDENT PRIEST AT THE PARISH THANKED ME FOR TREATING FATHER FORTIER WITH RESPECT AND DIGNITY THROUGHOUT THE INVESTIGATION.

DURING THE RIDE BACK TO FARMINGTON FROM NASHUA FORTIER APPEARED VERY NERVOUS AND SIGHED SEVERAL TIMES HOWEVER NEVER SAID A WORD. AFTER THE BOOKING PROCESS I READ FORTIER MIRANDA WARNINGS AND HE INVOKED HIS RIGHT TO REMAIN SILENT. THE SIGNED MIRANDA FORM ACCOMPANIES THIS REPORT.

AT THE ROCHESTER DISTRICT COURT ATTORNEY DUBAY ARGUED BAIL ISSUES AND JUDGE JONES SET BAIL AT \$20,000.00 CASH OR SURETY. FORTIER WAS TRANSPORTED TO THE STRAFFORD COUNTY JAIL WERE HE POSTED HIS BAIL WITHIN A COUPLE OF HOURS OF ARRIVAL.
