On 09-25-02, I checked the Manchester Police Department records in an attempt to gather information regarding Father Philip Petit. There is a reference in Petit's file to an incident that took place in Manchester back in 1980 or 81, in which Petit admitted to a homosexual encounter with a "young man". Petit is said to have provided information to the Manchester Police Department regarding this unknown male subject, but I was unable to find anything relating to that incident or any contacts whatsoever with Philip Petit. Petit's name does not appear anywhere in the Manchester Police Department's record system and no further information has been obtained to date.

Collarusso advised that he checked his department's records and the Dover Police Department has no record of any contacts with Philip Petit during this or any other time period.
